In consideration of being permitted to compete, officiate, observe, work for, or participate in any way in the events or being permitted to enter for any purpose any RESTRICTED AREA (defined as any area requiring special authorization, credentials, or permission to enter any area to which admission by the general public is restricted or prohibited), I, THE UNDERSIGNED, for myself, my personal representatives, heirs and next of kin:

- ✓ State I am a driver, mechanic, pit crew or other team member, or other participant engaged in racing, and I am not participating in the EVENTS or entering the RESTRICTED AREA for recreational purposes.
- ✓ Acknowledge, agree, and represent that I have or will immediately upon entering any such RESTRICTED AREA and will continuously thereafter, inspect the RESTRICTED AREA which I enter, and I further agree and warrant that, if at any time, I am in or about the RESTRICTED AREA and I feel anything to be unsafe, I will immediately advise the officials of such and if necessary will leave that RESTRICTED AREA.
- ✓ HEREBY RELEASE, WAIVE, DISCHARGE and COVENANT not to sue the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, sponsors, advertisers, owners and lessees of premises used to conduct the events, premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss of control activities regarding the premises or Events and each of them, their directors, officers, agents and employees, all for the purposes herein referred to as "Releasees" from ALL LIABILITY TO THE UNDERSIGNED, my personal representatives, assigns, heirs, and next of kin for any and all loss or damage and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned arising out of or related to the events, whether caused by the Releasees or otherwise.
- ✓ Hereby agree to indemnify and save and hold harmless the releasees and each of them from any loss liability damage or cost they may incur arising out of or related to the events whether caused by the negligence of releasees or otherwise.
- ✓ Hereby assume full responsibility for any risk of bodily injury, death or property damage arising out of or related to the events whether caused by the negligence of releasees or otherwise

- ✓ Hereby acknowledge that the activities of the events are very dangerous and involve the risk of serious injury and/or death and/or property damage. I, the undersigned, also expressly acknowledge that injuries received may be compounded or increased by negligent rescue operations or procedures of the releasees.
- ✓ Hereby agree that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releasees, including negligent rescue operations and is intended to be as broad and inclusive as is permitted by the laws of the State of New York in which the events are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

- ✓ As a participant at DTRP, I am aware that to be eligible for any point fund monies, I am required to display any appropriate sponsor decals in the designated areas of my race car throughout the entire race season, join the FOAR Score Club no later than July 31st 2010, and I must participate in any additional fundraising efforts according to the requirements set by DTRP.
- ✓ I am aware that all pit pads at DTRP are reserved on a yearly first paid, first reserved basis and acknowledge that if I miss the published deadline for pad renewal, I may lose my preferred parking pad. I also acknowledge that I am not guaranteed my preferred pit pad from year to year, but appreciate that DTRP will do their best to accommodate my request.
- ✓ As a participant at DTRP, I acknowledge that I must be present at the 2010 banquet to receive any of the above point fund monies. If I do not attend, those monies will be available at the 2011 Membership/Registration party.
